Throughout the biological world, bacteria thrive predominantly in surface-attached, matrix-enclosed, multicellular communities or biofilms, as opposed to isolated planktonic cells. This choice of lifestyle is not trivial, as it involves major shifts in the use of genetic information and cellular energy, and has profound consequences for bacterial physiology and survival. Growth within a biofilm can thwart immune function and antibiotic therapy and thereby complicate the treatment of infectious diseases, especially chronic and foreign device-associated infections. Modern studies of many important biofilms have advanced well beyond the descriptive stage, and have begun to provide molecular details of the structural, biochemical, and genetic processes that drive biofilm formation and its dispersion. There is much diversity in the details of biofilm development among various species, but there are also commonalities. In most species, environmental and nutritional conditions greatly influence biofilm development. Similar kinds of adhesive molecules often promote biofilm formation in diverse species. Signaling and regulatory processes that drive biofilm development are often conserved, especially among related bacteria. Knowledge of such processes holds great promise for efforts to control biofilm growth and combat biofilm-associated infections. This volume focuses on the biology of biofilms that affect human disease, although it is by no means comprehensive. It opens with chapters that provide the reader with current perspectives on biofilm development, physiology, environmental, and regulatory effects, the role of quorum sensing, and resistance/phenotypic persistence to antimicrobial agents during biofilm growth.

Biofilms and Implantable Medical Devices

The bacterial flagellum is a supramolecular motility machinery consisting of the basal body acting as a rotary motor, the hook as a universal joint and the filament as a helical propeller. The bacterial flagellar motor composed of a rotor ring and a dozen stators is powered by an electrochemical-potential difference of specific ions across the cytoplasmic membrane and rotates in either the counterclockwise (CCW) or clockwise (CW) direction. A sensory signal transduction pathway regulates the switching between the CCW and CW states of the motor in response to environmental stimuli, allowing bacterial cells to migrate more desirable environments for their survival. The core structure of the bacterial flagellum is conserved among bacterial species. However, recent structural analyses of intact flagellar structures derived from various bacterial species by electron cryotomography and subtomogram averaging have shown that novel and divergent structures surround the core structure, suggesting that the flagellar motors have adapted to function in various environments of the habitat of bacteria. This Special Issue of Biomolecules covers recent advances in our understanding of and perspectives on the flagellar motor derived from different bacterial species.

Criminal Poisoning

This Special Issue features recent data concerning thioredoxins and glutaredoxins from various biological systems, including bacteria, mammals, and plants. Four of the sixteen articles are review papers that deal with the regulation of development of the effect of hydrogen peroxide and the interactions between oxidants and reductants, the description of methionine sulfoxide reductases, detoxification enzymes that require thioredoxin or glutaredoxin, and the response of plants to cold stress, respectively. This is followed by eleven research articles that focus on a reductant of thioredoxin in bacteria, a thioredoxin reductase, and a variety of plant and bacterial thioredoxins, including the m, f, o, and h isoforms and their targets. Various parameters are studied, including genetic, structural, and physiological properties of these systems. The redox regulation of monodehydroascorbate reductase, aminolevulinic acid dehydratase, and cytosolic isocitrate dehydrogenase could have very important consequences in plant metabolism. Also, the properties of the mitochondrial o-type thioredoxins and their unexpected capacity to bind iron-sulfur center (ISC) structures open new developments concerning the redox mitochondrial function and possibly ISC assembly in mitochondria. The final paper discusses interesting biotechnological applications of thioredoxin for breadmaking.

This book explores the broad and diverse biological and physiological impacts of established and newly discovered cyclic di-nucleotide second messenger signaling systems, while also providing descriptions of the intriguing biochemical characteristics of multiple turnover enzymes and receptors. The respective chapters discuss the commonalities and diversity of cyclic di-GMP, cyclic di-AMP and recently discovered cyclic GMP-AMP signaling systems in manifold Gram-negative and Gram-positive bacteria. The global human pathogens *Mycobacterium tuberculosis*, *Vibrio cholerae*, *Salmonella typhimurium*, *Escherichia coli* and *Streptococcus pneumoniae*, the facultative human pathogen *Pseudomonas aeruginosa*, global plant pathogens as exemplified by *Xanthomonas campestris* and *Burkholderia* spp., and the omnipresent probiotic *Lactobacilli*, as well as environmentally important photoautotrophic cyanobacteria, the multicellular *Myxococcus xanthus*, and chemolithotrophic *Acidithiobacillus* are among the representatives of the microbial kingdom that are described. In turn, the various aspects of bacterial physiology affected by these signaling systems- e.g. biofilm formation and dispersal, the cell cycle, motility, virulence, production of antimicrobials, fundamental metabolism and osmohomeostasis - are discussed in detail in the context of different microorganisms. Dedicated chapters focus on the population diversity of cyclic dinucleotide signaling systems, their tendency to be horizontally transferred, the cyclic di-GMP signaling system in the social amoeba *Dictyostelium*, honorary cyclic (di)nucleotides, and the development of strategies for interfering with cyclic dinucleotide signaling in order to manipulate microbial behavior. Taken together, the chapters provide an authoritative source of information for a broad readership: beginners and advanced researchers from various disciplines; individuals seeking a broad overview of cyclic di-nucleotide signaling; and those who want to learn more about specific aspects. Also featuring reviews with a forward-looking perspective, the book offers a valuable source of inspiration for future research directions.

Between the 1840s and the 1920s came most of the important information-processing and communication technologies still in use today: telegraphy, modern bureaucracy, rotary power printing, the postage stamp, paper money, typewriter, telephone, punch-card processing, motion pictures, radio, and television. Beniger shows that more recent developments in microprocessors, computers, and telecommunications are only a smooth continuation of this "Control Revolution." Along the way he touches on many fascinating topics: why breakfast was invented, how trademarks came to be worth more than the companies that own them, why some employees wear uniforms, and whether time zones will always be necessary. The book is impressive not only for the breadth of its scholarship but also for the subtlety and force of its argument. It will be welcomed by sociologists, economists, historians of science and technology, and all curious in general.

The Montebello Islands are a cluster of small, low relief land masses, comprised of ancient limestone, with skeletal soils, sparse vegetation and shifting sand bodies. They lie some 80 km from the coastline, representing far flung 'high points' on the once extensive arid coastal plains of north-west Australia. Barrow Island lies between the mainland and the islands. More famous as the first nuclear testing site used by the British in the 1950s and the location of the first known shipwreck off the Australian coast, (the Tryal in 1622), the Montebello Islands represent a unique configuration of terrestrial and marine ecosystems. This paper reports on archaeological analysis carried out on assemblages recovered from two stratified cave sites on Campbell Island in the Montebello group in northwest Australia. These sites provide unique insights into human responses to the drowning of the extensive arid plains of north-west Australia following the Last Glacial Maximum. Rich faunal assemblages have been recovered which date to the period 30,000-7000 BP as the local environmental context changed in response to the post-glacial marine transgression. Field surveys and excavations were carried out over two field seasons between 1992-4 and involved a team of archaeologists, field assistants and support crew.
