The basic premise of problem-based learning is that a true-to-life clinical problem is used as the stimulus for learning. The author has provided a series of vignettes and case-based problems that cover the spectrum of pediatric practice. The clients in these cases range in age from infancy to middle childhood and present with various medical diagnoses and occupational performance problems in a variety of practice settings. The cases raise important learning issues for further study, such as the use of theoretical frames of reference, models of practice, assessment tools, teamwork collaboration, and state-of-the-art research. Through the exploration of the problem, the learner engages in the process of critical thinking while applying and integrating new information and uses clinical reasoning for determining the role of occupational therapy. Although *Clinical Cases* was written primarily for occupational therapy educators and their students, practicing pediatric therapists also may find this text a valuable

learning resource for professional development and continuing education. In its entirety, this book constitutes an extensive pediatric PBL curriculum that is ideally suited for teaming in small groups with a tutor or facilitator; however, individuals and small informal groups of learners can easily design their own program of study using the summary table at the beginning of each module.
